



PARTNERSHIP AGREEMENT FOR WORLD EARTH DAY 2022

Between:

UNITY of NATIONS ACTION for CLIMATE CHANGE COUNCIL (UNAccc), a Non-profit international organization affiliated to NITI Aayog (DARPAN) and registered under Companies Act 2013, (ROC – Govt of India) Gujarat, PIN-390012, India.

AND

MY CODING CLASS an organization doing business as proprietary company , registered in Bangalore, MSME registration no UDYAM-KR-03-0075570 and whose office is located at Bangaluru-562157.

Partnership Parameters

1. UNAccc and My Coding Class share common goals and objectives with regards to the conservation, protection, enhancement and support of nature and natural resources, contributing to the fight against climate change and the preservation of biodiversity worldwide; and wish to collaborate to further these common goals and objectives of SDG within their respective mandates and governing rules and regulations.

2. Both the above mentioned parties hereby agree that:

(a) **UNAccc will provide My Coding Class with their logo** (the “UNAccc Logo”) that Partner can distribute along with **World Earth Day 2022 materials** during promotion, activities and for release of certificates to the participants. Partner only has the right to use the trademarked logo until 30 April 2022. Partner does not have the permission to transfer the right to use the UNAccc Logo or connected promotional material to any other entity not agreed upon. UNAccc has the right to revoke permission for Partner to use the UNAccc logo and all the connected material upon ten (10) days written notice in case any misuse is noticed/ reported.

(b) UNAccc will list **My Coding Class’s** event being undertaken till World Earth Day 2022 on their website **unacc.org** and **unacc.world** under Events page and the activities of UNAccc including the summit will be hosted on My coding class website www.mycodingclass.in with UNAccc logo.

(c) **My Coding Class** will provide UNAccc digital presence on their web site www.mycodingclass.in along with a link to UNAccc webpages www.unaccc.org and www.unaccc.world till 30 April 2022. My coding will also sponsor 10 licences of their 100 hour coding package as part of World Earth day 2022 promotion, which shall be distributed free of charge to deserving participants.

3. Partners will disseminate information to its network about the joint World Earth Day 2022 initiatives as planned and to be undertaken.

4. **Ownership of UNAccc Logo and material of the World Earth Day**

MY CODING CLASS agrees that it has no right to use the UNAccc Logo or WORLD EARTH DAY 2022 Materials (or any translation thereof) except as provided in this License and all uses of the UNAccc Logo by the Partner, and the associated goodwill, shall insure solely to the benefit of UNAccc and your company as decided.

IN NO EVENT WILL UNAccc BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES OR EXPENSES ARISING IN CONNECTION WITH THIS AGREEMENT OR THE USE OF THE UNAccc LOGO AND WORLD EARTH DAY 2022 MATERIALS, EVEN IF UNAccc IS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

6. **Costs** Each party shall be responsible for its own costs associated with this Agreement and its obligations hereunder.

7. **Official Emblems and Logos**

Both Party shall use the name, emblem or trademarks of the other Party, its subsidiaries, affiliates, and/or authorized agents, or any abbreviation thereof, in publications and documents produced by the Parties, with the express prior written approval of the other Party in each case; provided, however, that both the Partner's has the right to use the UNAccc Logo and translation thereof as provided herein.

8. **Agreement**

8.1 This Agreement shall enter into effect on the date of signature of both the parties.

8.2 This Agreement is governed by and construed in accordance with the laws of the Government of India and changes as happen from time to time.

8.3 This Agreement may be amended only with the consent of both parties.



8.5 Each party reserves its rights to terminate this Agreement upon thirty (30) days written notice to the other party. In addition, UNAccc may immediately terminate this Agreement in the event that UNAccc believes that the Partner breached any material condition of this Agreement or UNAccc otherwise believes the termination is in UNAccc's best interests, as determined in UNAccc's sole discretion.
